Making a Bequest to the Big Issue In Australia Limited:

Bequest Wording:

1. The residue of your estate

After you have taken care of your family, friends and any debts, you can leave any remaining money to Big Issue In Australia Limited. This is called a residuary bequest because it means the residue (or remainder) of your estate. Correct wording for a residuary bequest:

I _____ (Name) of _____ (address) give and bequeath, free of all duties and taxes payable at my death (if any) the rest and residue of my estate both real and personal to Big Issue In Australia Limited (ABN 61 071 598 439) for its use and general purposes and declare that the receipt of an executive officer at the time, shall be sufficient discharge of my executor's duty.

2. A percentage of the residue of your estate

An alternative to a residual bequest is to give a percentage of the residue of your estate. Correct wording for a residuary bequest:

I _____ (Name) of _____ (address) give and bequeath, free of all duties and taxes payable at my death (if any) _____ per cent of the residue of my estate to Big Issue In Australia Limited (ABN 61 071 598 439), for its use and general purposes and declare that the receipt of an executive officer at the time, shall be sufficient discharge of my executor's duty.

3. A percentage of your total estate

An alternative to a residual bequest is to give a percentage of your entire estate, up to 100 per cent. Correct wording for a residuary bequest:

I _____ (Name) of _____ (address) give and bequeath, free of all duties and taxes payable at my death (if any) , _____ per cent of my entire estate to Big Issue In Australia Limited (ABN 61 071 598 439) for its use and general purposes and declare that the receipt of an executive officer at the time, shall be sufficient discharge of my executor's duty.

4. A specific amount

You may choose to leave a specific amount of money from your estate to Big Issue In Australia Limited. Correct wording for a specific amount:

I _____ (Name) of _____ (address) give and bequeath, free of all duties and taxes payable at my death (if any) , the sum of \$_____ to Big Issue In Australia Limited – (ABN 61 071 598 439) for its use and general purposes and declare that the receipt of an executive officer at the time, shall be sufficient discharge of my executor's duty.
